Information We Collect

Personally Identifiable Information (PII)

We do **not** sell your personal information.

How We Protect Your Information

- Payment transactions are processed through **third-party PCI-compliant payment processors**; we do not store or process credit card data directly.
- Access to personal information is limited to authorized personnel.
- While no method of transmission over the internet is 100% secure, we strive to use commercially acceptable means to protect your information.

You can control cookie settings through your browser. Disabling cookies may affect site functionality.

- Data shown in the comments form
- IP address
- Browser user agent string (for spam detection)

An anonymized hash of your email may be shared with Gravatar.

Media Uploads

If you upload images, avoid including embedded location data (EXIF GPS). Visitors may extract this information.
